Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 08.00 crore bank facilities of Sri Laxminarasimha Industries (SLI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SLI was established by Mr. Arogya Reddy, Mr. Raji Reddy, Mr. Chandrashekhar Rao and others in November 2015. The firm plans to set up an automated ginning and pressing unit with 36 Double Roller Gins at Karimnagar (Telangana). The operations are expected to commence post August, 2016. The total project cost is estimated to be Rs.6.47 crore out of which Rs.3.12 crore is to be funded by partners and the balance through a term loan.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
