SMERA has reviewed long-term rating of '**SMERA B+**' (read as **SMERA B plus**) and short term rating of '**SMERA A4**' (read as '**SMERA A four**') on the Rs. 6.00 crore bank facilities of Envy Cylinders Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity

The Andhra Pradesh-based Envy Cylinders Private Limited (ECPL), established in 1998 is engaged in the manufacture of LPG cylinders. The company supplies cylinders to oil companies such as IOCL, HPCL and BPCL and has an installed capacity of around 46000 cylinders per month.

For FY2014-15, ECPL reported profit after tax (PAT) of Rs.0.05 crore on total operating income of Rs. 37.45 crore, compared to PAT of Rs (0.02) crore on total operating income of Rs.29.35 crore in FY2013-14.
