Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB-' (read as ACUITE double B minus)**' on the Rs. 5.79 crore bank facilities of Prithvi Innerwears. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Prithvi Innerwears (PI) was established in 2009, is a Tirupur (Tamil Nadu) based partnership firm engaged in manufacturing of inner wears for women and kids. The entity has a manufacturing facility located in Tirupur with an installed capacity of 50,000 pieces per day. The entity is promoted by S. Balan and B. Poongodi. Both the partners are active in day to day operations of the firm.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
