Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 14.00 crore bank facilities of Taleda Square Private Limited (TSPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Taleda Square Private Limited (TSPL), incorporated in 2014, is a Pune-based company promoted by Mr. Harshad Talera and Mr. Praveen Mutha. A 100 per cent subsidiary of Smart Hotels Private Limited, the company has established a multifunctional complex under the name 'Taleda Square' at Ajmer (Rajasthan). The complex comprises commercial units (12 shops) and a budget hotel, Smart Inn with 90 rooms. The land has been leased by Rail Land Development Authority (RLDA) for a period of around 45 years. The construction of the hotel is underway and is expected to be completed by March, 2018.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
