Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D)on the Rs.9.50 crore bank facilities of Arihant Wheels & Cycles Private Limited (AWCPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Arihant Wheels & Cycles Private Limited (AWCPL), incorporated in 2007, is an Uttar Pradesh based company promoted by Mr. Chetan Choudhary. The company manufactures bicycles and spares.

Non-cooperation by the issuer/borrower:
