Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.9.50 crore bank facilities of Arihant Wheels & Cycles Private Limited (AWCPL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Arihant Wheels & Cycles Private Limited (AWCPL), incorporated in 2007, is an Uttar Pradesh based company promoted by Mr. Chetan Choudhary. The company manufactures bicycles and spares.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
