Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE D**' (read as **D**) on the Rs. 40.44 crore bank facilities of Ferromet Steels Private Limited (FSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ferromet Steels Private Limited (FSPL), incorporated in 1995 and located in Tamil Nadu. It is engaged in the manufacture of mild steel (MS) bars, MS Angle, MS round, MS square. The company was promoted and managed by Directors, Mr. Manmohan Mittal and Mr. Ashok Kumar Goe

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
