Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.18.00 Cr bank facilities of Forest Press Machineries Private Limited (FPMPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Forest Press Machineries Private Limited (FPMPL) was incorporated in 2015 by Mr. Manoj Kumar Pillai (MD, Hess India) and Mr. Peter Bullock (Chairman, Forest Press Hydraulics, UK). The company is engaged in the assembling, testing and selling of industrial machinery used in the production of building materials for construction and infrastructure industries. FPMPL specialises in wet-press and wet-cast technology in the Indian market. The manufacturing unit is located at Bommasandra in Bangalore (Karnataka).
