**Rating Rationale**

Acuité has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) and reaffirmed the short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs.18.00 Cr bank facilities of Forest Press Machineries Private Limited (FPMPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Forest Press Machineries Private Limited (FPMPL) was incorporated in 2015 by Mr. Manoj Kumar Pillai (MD, Hess India) and Mr. Peter Bullock (Chairman, Forest Press Hydraulics, UK). The company is engaged in the assembling, testing and selling of industrial machinery used in the production of building materials for construction and infrastructure industries. FPMPL specialises in wet-press and wet-cast technology in the Indian market. The manufacturing unit is located at Bommasandra in Bangalore (Karnataka).

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity.
