Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus)from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 61.25 crore bank facilities of Bharat Engineering Construction Company Private Limited(BECC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Tamil Nadu-based,Bharat Engineering Construction Company Private Limited(BECC) was incorporated in 2006 by Mr. H. Syed Abdul Kader and Mr. M.S. Thaika Sahib. The company undertakes infrastructure projects related to water supply, sewerage and solid waste management apart from constructing roads, bridges, flyovers and dams. The company has also executed a real estate project 'Alpha Lotus Towers' at Avadi (Chennai)in FY 2017.

Non-cooperation by the issuer/borrower:
