### Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.14.11 crore bank facilities of CLH Gaseous Fuel Applications Private Limited (CLH). This rating is now an indicative rating and is based on best available information.

**Non-cooperation by the issuer/borrower:** Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### About the Rated Entity:

CLH, is a Delhi-based company, incorporated in 2006 by Mr. Shishir Agarwal, and Mr. Gagan Agarwal. The company is engaged in the designing and manufacturing of alternate fuel system, kits for engines and buses among others. The company has also begun manufacturing of Electric Rickshaws (Erickshaws) for the domestic market from December 2015.

The company reported profit after tax (PAT) of Rs.0.99 crore on net sales of Rs.41.32 crore in FY2017 as against net loss of Rs.0.64 crore on net sales of Rs.11.71 crore in FY2016. The net worth stands at Rs.6.32 crore as on 31 March 2017 compared to Rs.6.97 crore as on 31 March 2016.
