Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.13.19 crore bank facilities of ALOM POLY EXTRUSIONS LIMITED (APEL). This rating is now an indicative rating and is based on best available information.

The Kolkata-based, APEL was incorporated in 2012 by Mr. Ajay Prakash Jhunjhunwala and Mr. Prakash Jhunjhunwala. The company is engaged in the manufacturing of corrugated polyethylene pipes including Double Wall Corrugated (DWC) and High Density Polyethylene (HDPE) Pipes for sewage, drainage and cable protection.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
