Acuité has reaffirmed the long-term rating of '**ACUITE C**' (read as **ACUITE C**) on the on the Rs.5.00 crore bank facilities of Aradhana Distributors Private Limited (ADPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.
