# **Rating Rationale**

Acuité has reaffirmed the long-term rating to 'ACUITE D' (read as ACUITE Do)n the Rs.15.00 crore bank facilities of Pyaridevi Chabiraj Steels Private Limited (PCSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### Non-cooperation by the issuer/borrower:
