SMERA has reviewed long-term rating of '**SMERA BB**' (read as **SMERA BB**) and short term rating of '**SMERA A4+**' (read as '**SMERA A four plus**') on the Rs. 8.30 crore bank facilities of The Palani Andavar Mills Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

The Palani Andavar Mills Limited (TPAML) was incorporated in 1933 by Mrs Girija Parthasarathy who possesses extensive experience in the textile industry. The company manufactures cotton yarn at Triupur, Tamil Nadu and has an installed capacity of 29,808 spindles. The company produced 12.66 lakh kg of cotton in FY2016.

The company clocked sales of Rs.27.60 crore for FY2014-15. The profit after tax (PAT) for FY2015 stood at Rs.0.36 crore.
