Acuite has reviewed the long term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 8.30 crore bank facilities of The Palani Andavar Mills Limited. This rating is now an indicative rating and is based on best available information.

The Palani Andavar Mills Limited (TPAML) was incorporated in 1933 by Mrs Girija Parthasarathy who possesses extensive experience in the textile industry. The company manufactures cotton yarn at Triupur, Tamil Nadu and has an installed capacity of 29,808 spindles.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
