About the Firm

CCC, incorporated in 1982, is a Guwahati-based partnership firm promoted by Mr. Sudhir Choudhary. The firm provides civil construction services and also undertakes EPC contracts.

For FY2013-14, CCC reported profit after tax (PAT) of Rs.0.34 crore on operating income of Rs.12.89 crore, as compared with PAT of Rs.0.13 crore on operating income of Rs.6.81 crore in FY2012-13. The firm reported revenue of Rs.19.05 crore (provisional) during April 2014 to February 2015. CCC's net worth stood at Rs.6.72 crore as on March 31, 2014, as compared with Rs.6.40 crore a year earlier.
