#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus)from 'ACUITE BB-' (read as ACUITE double B minus) and the short-term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs.65.00 Crore bank facilities of KCVR Infra Projects Private Limited (KCVR) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
