Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.6.00 crore bank facilities of Apace Builders and Contractors Private Limited (ABCPL). This rating is now an indicative rating and is based on best available information.

ABCPL, established in 2015, is a Noida-based company promoted by Mr. Rupendra Kumar Shukla and Mr. Prashant Kumar Shukla. The company undertakes civil structural work for infrastructure projects such as housing complexes, commercial office buildings and IT parks, among others.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
