Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B (read as ACUITE B)' from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 6.00 crore bank facilities of Apace Builders and Contractors Private Limited (ABCPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Apace Builders and Contractors Private Limited (ABCPL), established in 2015, is a Noida based company promoted by Mr. Rupendra Kumar Shukla and Mr. Prashant Kumar Shukla. The company undertakes civil structural work for infrastructure projects such as housing complexes, commercial office buildings and IT parks, among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
