Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of Mustafa Gold Mart. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Mustafa Gold Mart (MGM) is a proprietorship firm established in 1999 by Mr. Mustaq Ahmed (Proprietor). The firm engaged in retailing of gold, platinum, silver and diamond studded ornaments. The firm has a showroom (spread over 4000 square feet area) in T. Nagar, Chennai. The overall operation of the firm is managed by Mr. Ishtiaq Ahmed (CEO).s.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
