Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.20.00 crore bank facilities of Geninfra Constructions. This rating is now an indicative rating and is based on best available information.

GC, a partnership firm established in 2010, is promoted by Mr. A. Naveen Kumar Reddy and others to undertake civil construction (mainly road construction) and irrigation projects. The firm is a Special Class Contractor in Telangana and Andhra Pradesh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
