Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of BMSS Steel Industries Private Limited (BSPL). This rating is now an indicative rating and is based on best available information.

Incorporated in 1987, BMSS Steel Industries Private Limited (BSPL) is a Maharashtra-based company promoted by Mr. Himatlal Garodia and Mr. Rajiv Garodia. The company is engaged in the trading of specialty steel used for manufacturing automobile components such as crank shafts, axle steering rods, to name a few. Since April 2017, the company has also begun processing of steel. Further, BMSS has its processing unit in Kalamboli (Navi Mumbai) with capacity of 400 tonnes per month.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
