Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.7.65 crore bank facilities of S.V.M. Motors Private Limited (SVMM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Chennai based, SVMM was incorporated in 2011 under the directorship of Mr. Saji Sebastian and Mr. Madhusudana Rao Karuparthi. SVMM is an authorised dealer of Honda Motors. The company is also involved in sale of two wheeler spare parts and accessories. It has three showrooms and two workshops in Chennai.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
