SMERA has reviewed short-term rating of '**SMERA A3**' (read as '**SMERA A three**') on the Rs. 15.00 crore bank facilities of SCOTTISH CHEMICAL INDUSTRIES. This is an indicative rating.

#### Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance and review of the rating. However, the issuer/borrower failed to submit required documents before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

#### About the rated entity

SCI, established in 1984 by Mr. Kamal Khandelwal, manufactures and exports foundry chemicals through its five manufacturing units - four at Taloja and one in China.

The firm reported profit after tax (PAT) of Rs.8.41 crore on net sales of Rs.81.66 crore in FY2015 as against PAT of Rs.7.40 crore on net sales of Rs.56.87 crore in FY2014.
