SMERA has reviewed long-term rating of '**SMERA B+**' (**read as SMERA B plus**) on the Rs. 7.00 crore bank facilities of Al-Safa Industries Private Limited. This rating is now an indicative rating and is based on best available information.

About the Rated Entity

The Uttar Pradesh based, AISPL was incorporated in 2013, by Mr. Sharafat Ali, Mr. Mohad Azeem and Mr. Dilshad Ahmed. The company trades in raw hides, poultry feed supplements, live animals, mutton tallow to name a few.

For FY2015-16 (Provisional), the company reported net profit after tax of Rs. 0.10 crore on total income of Rs.61.08 crore as against net profit after tax of Rs.0.07 crore on total income of Rs.58.93 crore a year earlier. The net worth stood at Rs.2.32 crore as on March 31, 2016 (Provisional), as compared with Rs.3.15 crore a year earlier. The total Networth of Rs.2.32 crore (includes quasi equity of Rs.1.12 crore as on March 31, 2016 provisional).
