Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 6.32 crore bank facilities of Bhavee Tex (BT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bhavee Tex (BT) is a Surat-based partnership firm established in 2015 by Mr. Lakshar Khunt and Mr. Mukesh Lukhi. The firm primarily manufactures knitted fabric.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
