Acuite has reviewed the long term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs.5.66 crore bank facilities of Bhagwat Tex (BT). This rating is now an indicative rating and is based on best available information.

BT was established in 2015 by Mr. Lakshar Khunt and Mr. Mukesh Lukhi. The firm primarily manufactures and designs knitted fabric in Surat (Gujarat).

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
