# **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minuso) n the Rs. 5.66 Cr. bank facilities of Bhagwat Tex (BT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

Bhagwat Tex (BT) was established in 2015 by Mr. Lakshar Khunt and Mr. Mukesh Lukhi. The firm primarily manufactures and designs knitted fabric in Surat (Gujarat).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
