### Rating Rationale

Acuité has reviewed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 14.50 crore bank facilities of Parvin Exim Private Limited. This rating is now an indicative rating and is based on best available information.
