**Rating Rationale**

Acuite has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 5.10 Crore bank facilities of Ganesh Impex (GI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Ganesh Impex (GI) established in 2009 is a Chennai-based proprietorship firm promoted by Mr. Sivakumar. The firm is engaged in the manufacture of aluminium utensils and induction cookware at its two manufacturing units at Chennai Tamil Nadu. The firm has a total production capacity of 22.20 tons per month.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry
