Acuite has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs.6.50 crore bank facilities of Western India Media Private Limited (WIMPL). This rating is now an indicative rating and is based on best available information.

WIMPL, incorporated in 2011 is a Surat-based publisher and distributor of 'Gujarat Guardian', a Gujarati daily. The company is headed by Mr. Manoj Mistry, Director.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
