Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs.6.50 crore bank facilities of Western India Media Private Limited (WIMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Western India Media Private Limited (WIMPL), incorporated in 2011 is a Surat-based publisher and distributor of 'Gujarat Guardian', a Gujarati daily. The company is headed by Mr. Manoj Mistry, Director.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
