# **Rating Rationale**

Acuité has reaffirmed the long term rating of 'ACUITE B-' (read as ACUITE B minuso)n the Rs. 6.50 crore bank facilities of Western India Media Private Limited (WIMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
