## Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE C**' (read as **ACUITE C**)' on the Rs. 11.00 crore bank facilities of Pinnacle Vehicles And Services Private Limited (PVSPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
