Acuite has reviewed the long-term rating of '**ACUITE BBB-**' (read as **ACUITE triple B minus**) to the Rs.15.00 crore bank facilities of Gemco Energy Limited (GEL). This rating is now an indicative rating and is based on best available information.

GEL was incorporated in 2010 and commenced commercial operations in August, 2013. The company operates an 8 Mega Watt (MW) biomass-power plant at Bhiwani (Haryana). It has obtained regulatory clearances and approvals for a second unit of 7 Mega Watt (MW) at the same site for which the land infrastructure set up has already been created.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
