SMERA has reviewed the long term rating of '**SMERA B**' (read as **SMERA B**) on the Rs.20.00 crore bank facilities of V.R. Nachimuthu. This rating is now an indicative rating and is based on best available information.

**Non-cooperation by the issuer/borrower:** SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

#### About the Rated Entity:

VRN was established in 1962, by the Late Mr. VR Nachimuthu. The firm is part of the Sakthi Group that has executed around 27 projects so far. It is headed by Mr. VN Subramanian, Partner, and a civil engineer with over three decades of experience in the construction industry.

For FY2015-16, the firm reported profit after tax (PAT) of Rs.0.28 crore on operating income of Rs.3.17 crore, as compared to PAT of Rs.2.08 crore on operating income of Rs.21.95 crore in the previous year.
