Rating Rationale

Acuite has reaffirmed the long term rating to **‘ACUITE D’ (read as ACUITE D)** and the short term rating to **‘ACUITE D’ (read as ACUITE D)** on the Rs.32.00 crore bank facilities of APLAB Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Aplab Limited is a Thane based company incorporated in 1962 by Mr. P.S Deodhar and is engaged as a manufacturer for Test & Measurement instruments. Originally, the company was called Applied Electronics Limited which later on went on to be called Applied Electronics Lab before the name was finally changed to Aplab Limited. The primary business activity involves the manufacturing of electrical/electronic equipment and devices. The company has reputed clientele such as Hindustan Aeronautics Limited, Bharat Electronics Limited, and L&T Limited, to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
