Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.7.40 crore bank facilities of Strong Plant Infrastructure Private Limited (SPIPL). This rating is now an indicative rating and is based on best available information.

SPIPL, established in 2010, is a Mumbai-based civil construction company that undertakes piling work i.e. laying foundation for telecom towers, metro pillars, buildings among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
