#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE BB-' (read as ACUITE double B minus) from 'ACUITE BB' (read as ACUITE double Ba)nd reaffirmed the short term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 8.50 crore bank facilities of Sarvottam Polymers Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

Sarvottam Polymers Private Limited, was incorporated in 1996 by Mr. Shyamlal Kishanlal Damani and family. The company manufactures plastic products (bottles, jars, plastic pumps and plastic caps, among others) at Silvassa and Vasai. The installed capacity stands at 250 tonnes per annum. The registered office is at Borivali.

# Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
