Rating Rationale

Acuité has reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 12.00 crore bank facilities of Reliable Clothing Private Limited (RCPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Reliable Clothing Private Limited (RCPL), incorporated in 2009, directed by Clotilda Raphael Sequeira, Colette Cletus Aaron Dlima, Cletus Aaron Stany Dlima, took over the textile business of Reliable Exports (Proprietorship concern). The company is engaged in the manufacture and export of readymade garments. RCPL has its manufacturing unit located in Kanjurmarg at Mumbai (Maharashtra) and has a capacity of producing 5-6 lac units per annum. Actual capacity utilisation is 80-90 percent.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
