Acuite has reviewed long-term rating of „**ACUITE BB-** (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4+** (read as '**ACUITE A four plus**') to the Rs. 5.50 crore bank facilities of S.C.S. Agro Impex Private Limited (SCPL). This rating is now an indicative rating and is based on best available information.

Incorporated on 15 March, 2006, the Chennai-based SCPL is engaged in the trading of poly granules. The company caters to manufacturers of plastic and polythene bags and covers, among others.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
