Acuité has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 23.25 crore bank facilities of SLS Power Limited (SPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SPL, incorporated in 1998, is a Nellore-based company promoted by Mr. M. S. Badrinarayana and Mr. V. Chenchaiiah. The company is engaged in the generation of biomass energy from agriculture waste and has a production capacity of 6 MW per annum.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
