Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minusa) nd the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 23.25 crore bank facilities of SLS Power Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SLS Power Limited, incorporated in 1998, is a Nellore-based company promoted by Mr. M. S. Badrinarayana and Mr. V. Chenchaiah. The company is engaged in the generation of biomass energy from agriculture waste and has a production capacity of 6 MW per annum.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management
