KMFL, incorporated in 1991 is engaged in the processing of milk into butter, ghee, Milk Powder, Whitener etc. KMFL is based out of Karnal (Haryana) and is promoted by Mr. Gian Prakash Gupta (Chairman), Mr. Vipin Gupta (Managing Director) and family.

KMFL reported net profit of Rs.0.98 crore on total income of Rs.145.51 crore for FY2013-14, as compared with net profit of Rs.0.76 crore on total income of Rs.118.29 crore in FY2012-13. The company's net worth stood at Rs.17.07 crore as on 31st March 2014, as against Rs.16.09 crore a year earlier. KMFL registered revenue of Rs. 160 crore (Provisional) in FY2014-15.
