**Rating Rationale**

Acuité has downgraded the long-term rating to '**ACUITE B**' (**read as ACUITE B**) from '**ACUITE B+**' (**read as ACUITE B plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 19.00 crore bank facilities of Karnal Milk Foods Limited (KMFL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Karnal Milk Foods Limited (KMFL) was incorporated in 1991 by Mr. Gian Prakash Gupta (Chairman), Mr. Vipin Gupta (Managing Director) and family is an AGMARK, BIS & ISI MARK certified company engaged in processing of milk into butter, ghee, Milk Powder, Whitener etc. and sells under the brand name of "Karan". The processing unit is in Karnal (Haryana). The company is mainly selling their products to clients like Britannia, ITC and Parle. Entire sale of the company is to corporate clients. The company is not engaged in the retailing of aforementioned milk products. The promoters of the company have more than three decades of experience in whole selling of milk products.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI

regulations and Acuité's policies.

### **Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
