### Rating Downgraded and Withdrawn

### Rating Rationale

Acuite has withdrawn and downgraded the long term rating to '**ACUITE BB**' (read as **ACUITE double B**) from '**ACUITE BB+**' (read as **ACUITE double B plus**) and the short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.17.00 crore bank facilities of Hero fashion (HF). The rating withdrawal is in accordance with Acuite's policy on withdrawal of rating. The downgrade is on account of information risk.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

The Tirupur-based, Hero Fashion is a proprietorship firm established in 1989 by Mr. S. Sundaramurthy manufactures and exports readymade garments (for men, women and kids). The manufacturing facility is located at Tirupur, Tamil Nadu and the installed capacity stands at 24 lakh pieces per annum.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Analytical approach

Acuite has considered the standalone financial and business risk profiles of CTCPL to arrive at this rating.
