Rating Rationale

Acuité has Reaffirmed the long term rating of 'ACUITE BB-' (read as ACUITE double B minus) and reaffirmed the short-term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 10.00 crore bank facilities of Bhoruka Charitable Trust (BCT). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Bhoruka Charitable Trust (BCT) was incorporated in 1962 in Jaipur by Mr. P D Aggarwal. The trust is engaged in the execution of health, water and sanitation projects for the state governments of Rajasthan, Karnataka and Andhra Pradesh. It also manages schools and colleges in Churu district, Rajasthan. Further, the trust has also established the Bhoruka Group of Industries. The current trustee of BCT is Dr. Ashok Agarwal.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit

rating is based.
