**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE C**' (read as **ACUITE C**) on the Rs. 20.70 crore bank facilities of Core Minerals. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Chennai – based firm established in 2004 by Mr. P. B. Anandam and family is engaged in the mining and trading of iron ore. The firm is part of the Archean group that has varied interests in granites, industrial salt and other chemicals

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
