Acuité has reviewed long-term rating of „**ACUITE BB**“ (read as **ACUITE Double B**) on the Rs. 25.00 crore bank facilities of R.K. Associates (RKA). This rating is now an indicative rating and is based on best available information.

The Karnataka-based RKA, incorporated in 1987, is a Super Grade LEC (Licensed Electrical Contractor) and also a Class I contractor under KPDW (Karnataka Public Work Department). The proprietorship firm is engaged in the construction of sub-stations and related electrical work in Karnataka.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.
